# When time is short...

Here's one subject they don't teach in law school: Death.

Timothy Tosta, a land use partner in Luce, Forward, Hamilton & Scripps' San Francisco office, has written a book about how to sit with a dying person. He has some personal experience: Twenty year ago, at 41, doctors told him he had cancer and had two years to live.

Tosta's thoughts are deep, but his advice is short. The

book—#DEATHtweet Book 02: 140 Perspectives on Being A Supportive Witness to the End of Life—offers 140 tips, each less than 140 characters long. It can even be downloaded as an iPhone app. He notes that books of this nature tend to be tomes written by doctors or religious leaders. "Death is much simpler than that," Tosta said. His book is a half-hour read. "Because of the nature of the tweet format, you have to get to the essence of what you're saying. There's no screwing around." —Amanda Bronstad

**DANGEROUS WEAPON** Florida pastor Terry Jones has shot and wounded his car. *The Detroit Free Press* reported that Jones' licensed .40-caliber pistol accidentally fired into the floorboard while he was entering the car following a television interview. Jones has been in court fighting for a permit to stage a protest outside a Dearborn, Mich., mosque. In March, Jones sparked deadly riots in Afghanistan by burning a Quran. —MICHAEL MOLINE



**CONTEXT COUNTS** Theodore Boutrous Jr. of Gibson, Dunn & Crutcher recalls that, last December, he was at the U.S. Court of Appeals for the 9th Circuit for oral arguments over

**EXAM JITTERS** The University of Florida Levin College of Law suspended professor Kenneth Nunn for a week for pushing a law student during final exams. *The Gainesville Sun* reported that Nunn mistakenly believed he had reserved a specific room in which to administer his criminal law exam. In fact, that room was already being used by students taking a tax exam. A confrontation ensued, and Nunn pushed the tax student with both hands. The suspension was not too disruptive to Nunn's teaching schedule. It took place during spring break. —Karen Sloan
